362.12 The Request for Proposals for this project should be completed by the end of this week.

362.13 The Clerk suggested that some of the above committee reports that originated from the 2010 Master Plan could now be considered operational and should not be required to make reports unless a special project was being undertaken.

362.15 The Clerk/Coordinator confirmed that all music entertainers have been hired. It is hoped and expected that the water supply project will not be at a stage that would affect the festival. The budget for this year's event was presented. Some of the changes from previous years were explained.

NEW BUSINESS

Association of Nova Scotia Villages (ANSV)

362.17 The Clerk attended the ANSV meeting held 6th May and reported that plans for the NASV Annual General Meeting to be held in Lawrencetown/Kingston in September are progressing. Any Commissioners wishing to attend should notify the Clerk so that accommodations can be booked. Some of the discussion, updates or potential changes to the Municipal Government Act were reported. The Pugwash Village Commissioners decided not to accept the offer from the Village of Kingston to pool capital resources.

TREASURER'S REPORT

362.20 The Clerk Treasurer presented the budget for 2017. There is no increase of village taxes again this year. However, as other costs tend to increase, there has to be a corresponding decrease of spending somewhere and this is seen in decreased budget for capital projects. The Clerk said that taxes have not changed for several years. The Clerk gave the opinion that the village has been operating on an artificially low (shoestring) budget for several years. For the village to continue to offer the services it currently provides, the tax rate may soon have to increase.

MOTION

362.21 It was moved by Commissioner Blackie and seconded by Commissioner Gould that the 2017 Budget be approved as amended.

362.22 Commissioner Blackie will work with the Clerk Treasurer to develop a Capital Investment Plan.
