CALL TO ORDER

PUGWASH AND DISTRICT VOLUNTEER FIRE DEPARTMENT – Chief Andy Yarrow - absent 376.9 No report

SIX RIVERS CHAMBER OF COMMERCE – Interim Chair, Bill Martin

376.10 Chair Martin explained that the change of name of the chamber from *Pugwash* and *Area* to *Six Rivers* to reflect the proposed wider coverage area of the chamber. *Think tanks* (community meetings) with will be held with communities within this area to consult as to their interest in tourism and community development. In keeping with past involvement in engaging the public with political life, a successful all candidates' debate (for Cumberland North) was held in Pugwash recently. Membership has risen in the past year from 50 to 90 and there are hopes, with the expanded coverage area, that this will increase further. Chair Martin reported that there will soon be a new chamber website. When asked, Chair Martin explained that the Six Rivers name refers to being those communities within the watershed of the Tidnish, Shinimicas, Philip, Pugwash, Wallace and Dewar Rivers.

PUGWASH COMMUNITIES IN BLOOM (CIB) – Chair Maureen Leahey

376.11 Mrs. Leahey presented her report, adding that they are making a financial contribution towards the cost of a part time gardener and that this is again a competing year for Pugwash.

2016 GATHERING OF THE CLANS – Coordinator Lisa Betts

376.12 Report presented as read. Ms Betts added that with the tall ships scheduled to be Pugwash over Canada Day, the various festivals involved are all working together to make for one big festival. Due to a change in the usual date and location of the National competition to July 1st, the Pugwash Highland Dance competition date is changed to August 12th.

376.13 Report presented as read

MUNICIPAL WATER SUPPLY - Justin Waugh-Cress, Director of Engineering and Operations for the Municipality of Cumberland County

376.14 Mr Waugh-Cress gave a verbal report. He reviewed the activities of work done last year with all but 2km of supply pipeline having been laid. The project has

since been extended to Pugwash Point and this work will be done this summer. The treatment plant is built and the reservoir tower (18m tall, glass lined steel) will be built this spring and provide gravity fed treated water to Pugwash. The last tender for the mechanical and treatment equipment at the wellfield will close next week. Three expansions to the system have been approved (Pugwash Point/Gulf Shore Road, Irishtown Road and to the fire station) and will be put in place this summer. Some other landscaping and other post excavation tidy-up not yet completed will be done this summer. The iron and manganese found in the wellfield water will be treated with a non-chemical Suez treatment system. Further free water testing has been approved by Council and this will be offered to residents this spring. A list of contractors qualified to make the domestic connections will soon be generated. There are plans for an Open House at the end of June. Access to the wellfield will be from the Rockley Road (Hwy 321). The reservoir tower will be too far away to display any wording or village logo that would be visible.
